## **Special Guest - Elizabeth Larson**

148 year old Hells Bend School House- to make the community aware of efforts to preserve the school house.

LARA - Lucerne Area Revitilization Association <u>https://www.lucerneara.org/</u> Kelseyville Unified has started the process to donate the school house. Two proposals have been made to the school district. One by Lake County Historical Society <u>https://www.lakecountyhistory.org/</u>, and one by LARA. #### CH BOX

The school house has been sitting in the same location in Kelseyville for 137 years. LARA's proposal includes keeping the school house where it is and have events at the site in Kelseyville. Testing has been done on asbestos and lead. No asbestos was found but lead was found in the paint. LARA is working with a consultant to determine next steps considering the environmental report. LARA hopes to weatherize the building for the winter but may be delayed due to test findings. Research will continue,

the school district agrees that the building should be preserved. Short term might call for tarping in way that doesn't draw attention.

## Status Update on Main Street Free WIFI Project - Rick White

The plan is to bring free WIFI from the pharmacy to State Street. Agreements are being drafted between the merchants and the KBA for fees and antenna placement. The membership does not want antennas put on the light posts, so work needs to be done to place them with local merchants. Probably 6-7 antennas (appx. 10" high).

## **Event Center - Lorna Sides**

Offered a handout that covered her last presentation on 7/8/19

The event center could use a few more rentals per month, and an annual fund raiser to support the center. A grant writer is still needed on the Board at the Event Center.

A recent quote to replace the floor is approximately \$14k with sheet vinyl for the kitchen and a vinyl floating floor for the meeting areas.

Lorna made a motion asking the KBA to gift \$7k towards the floor replacement. No 2<sup>nd</sup> motion was offered

Lorna made another motion asking the KBA gift \$5k towards the floor replacement. No 2<sup>nd</sup> motion was offered.

Member comments:

Mark Borghesani- in the past the group has asked for the Center to put together a fund raiser and this hasn't happened. Considering that KBA budgets have not been set for 2020, \$5k is too high to ask for. Suggests that the Center solicit volunteers to come in and donate the labor to cut the costs on replacing the floor.

## Movie Night Big Oak Ranch - Brian Fisher

July Rising (filmed in Lake County by a Kelseyville High grad) is premiering on the lawn at the Ranch. This is a fund raiser with wine and beer sold under an ABC license.

## **Christmas in the Country - Brian Fisher**

Committee is in place. Decorations going up on the 9<sup>th</sup> of November. Research is being done on lighting the bridge for the event. New this year - Assembling the largest group of carolers to sing the 12 Days of Christmas to qualify for the Guiness Book of Word Records. The application process is 12 weeks long and needs to be expedited at cost. Brian asked the members for donations. The KBA will write the check directly for the application and then be reimbursed by member donations as follows:
